Council: Gentlemen—As a part of the construction of the John C. Lodge Expressway, an agreement was entered into on June 30, 1947, between the Michigan State Highway Department, Board of Wayne County Road Commissioners, City of Detroit, and the Fort Street Union Depot Company, Chesapeake and Ohio Railroad, Pennsylvania Railroad and Wabash Railrcad. Pursuant to the terms of the agreement the City of Detroit was deeded certain land in block bounded by Eighth Street, vacated Brooklyn Avenue, Fort Street and W. Jefferson Avenue. An easement was granted to the City of Detroit for other lands within above described limits by the Union Depot Company, all for the purpose of opening a new street between Fort Street and Jefferson Avenue, and crossing under the tracks of the Union Depot Company.

As a part of the agreement, and for construction purposes, the street was heretofore referred to as the "Fort-Jefferson Connection." It is desirable, however, to have a permanent name for this street which is to be taken over as a City obligation, in lieu of

the closing of Sixth Street. I would suggest the choice of the hame "Cabacier" for this new street, which would be after Joseph Cabacier who lived on the banks of a creek approximately with the wighten approximately where the Michigan Central tracks are now located. This creek flowed into the River Savoyard, a short distance from its outlet, and the Detroit River. This was originally and laid on the table.

known as May's Creek, being named after an early judge of the Court of Quarter Sessions, and, subsequently, as Campau River, about the middle of the 18th Century. Inasmuch as the names "May" and "Savoy" already designate streets in Detroit, the latter name of "Cabacier" would eliminate confusion and form a link with De-troit's earliest history.

Gentlemen—There is returned herewith the request of His Honor, the Mayor, to name the new street in the block bounded by Eighth, Brooklyn, Fort and Jefferson, "Cabacier."

Investigation discloses that street is being opened in connection with the construction of the John C. Lodge Expressway and that it will be the most important connecting link between Fort and Jefferson in area. There is not, now, in the City cf Detroit any street name resembling Cabacier, so that there would be no confusion resulting from identity with other street names.

In view of the above circumstances, the City Plan Commission can see no objection to the name of the new street in accordance with the wishes of Mayor Van Antwerp.

AN ORDINANCE designating the new thoroughfare in block bounded by Eighth Street, vacated Brooklyn Avenue, Fort Street and West Jefferson Avenue as Cabacier Street.

IT IS HEREBY ORDAINED BY THE PEOPLE OF THE CITY OF DETROIT:

Section 1. That the thoroughfare in block bounded by Eighth Street, vacated Brooklyn Avenue, Fort Street, and West Jefferson Avenue, 92 feet in width, the west line of which intersects with the south line of Fort Street at a point 84.09 feet east of the intersection of the east line of Eighth Street with the south line of Fort Street, be and the same is hereby designated and shall hereafter be known as Cabacier Street.

Section 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.
