tradesmen, only husky white laborers will be taken in any number; physical standards continue to be rigid; construction hiring should continue its slow rate of increase but remain selective with respect to common labor. All of the competent building tradesmen have already gone back to work. Extra good laborers will find no trouble in securing employment in the construction industry during the coming week. Service hiring should begin to slow down next week but not seriously. We expect to secure about the same number of hiring

this week as last.

At the present time, 1,125 persons are working out their relief on Work Relief projects in the various City

departments.

Similar reports to this will be presented weekly in accordance with your request and we would appreciate any suggestions which you have for the inclusion of additional information.
