Gentlemen-On May 11, 1948 we addressed a communication to your Honorable Body in which we quested the dedication of a parcel of property located in private claim 669 loquired by this Board in connection with the plan for the widening of Schaefer Road to its ultimate width of right of way of 120 feet.

This property is owned by the City of Detroit and known as the Schaefer

Recreation site. We understand there is a possibility of abanuoning this site as a park and disposing of it for private use. We recommend therefore that the property required for the monument in the east line of Beatrice Avenue thence N. 71 degrees. 52 is a possibility of abandoning this in the description enclosed be dedicated to this Board for highway purposes.
