> City Plan Commission January 11, 1952.

Honorable Common Council:

Gentlemen-The City Plan Commission has received a communication from the Department of Parks and Recreation requesting the extension of Bush Avenue and the widening of Pointer Avenue, also the 8 foot N/S alley, all of the above being located between Conant and Fleming Avenues south of Eight Mile Road.

The above mentioned streets and alley are adjacent to the St. Aubin-Pointer Playfield. Bush Avenue, if extended easterly, would provide an outlet for Lumpkin Avenue and the N/S

alley first westerly thereof. Pointer Avenue has a width of only 25 feet, westerly of Lumpkin and was dedicated from the subdivision to the south. The widening of Pointer Avenue to a 60 foot right-of-way would facilitate the flow of traffic from Lumpkin westerly to Conant. The N/S alley, westerly of Fleming and extending north and south of Winchester is collected to the state of th chester, is only 8 feet wide. This is insufficient to permit the passage of motor vehicles, and being a residen-tial alley an additional 10 feet in width would be desirable.

The land necessary for the widening of the above described streets and alley will have to be acquired from land under the jurisdiction of the Department of Parks and Recreation. All interested City departments have been contacted and there are no ob-

jections to the proposal.

After careful consideration of all the factors involved it is the recommendation of the City Plan Commis-sion that land be set aside from the St. Aubin-Pointer Playfield for the extension of Bush Avenue between St. Aubin and Lumpkin, also the widening of Pointer Avenue westerly of Lumpkin. Further, that the right-of-way of the 8 foot N/S alley westerly of Fleming and extending north and south of Winchester be increased to 18 feet. All of the above being shown on attached plan No. 932-1.
