## Purchases and Supplies January 12, 1954.

Honorable Common Council:

Gentlemen-When this department took over the operation of the Farmers' Public Markets, we found the been Concessions had Lunchroom paying 5% of gross revenue for the privilege. On the basis of inquiries, we found that a rate of 10 to 12% was customary for comparable operations, and we accordingly advertised for bids for a three year contract. The rate we obtained at the Eastern Market was 15%, and at the Western Market 15.19% of the gross sales. This included Cigarettes which are sold at a much lower profit than food.

Under date of August 26, 1952, your Honorable Body granted an extension of three years at the Eastern Market in return for the concessionaire's deeding to the City a fourth unit in the upper section of the market, making four operating units in all. This has improved the service and

increased the City's revenue.

The concession at the Western
Market is held with Jerry Boglarsky
and is due to expire on March 31, 1954. His operation, as in the case of the concession at the Eastern Market, has been handled in a very satisfactory manner. The gross sales at the Western Market have increased from \$28,000.00 prior to his operation in 1950, to \$34,000.00 in 1953, being an increase of  $21\frac{1}{2}\%$ , although the patronage in 1950 was  $16\frac{1}{2}\%$  higher than at present. It is our feeling that the percentage of return is at the highest level which it can be the highest level which it can be without having an adverse effect on the quality of the goods sold and the gross sales to be made.

We, therefore, respectfully request permission to continue these contracts in effect at the present rates, with the City reserving the right to discontinue the arrangement on thirty days' notice whenever, in our opinion, such action is deemed to be in the

City's best interests.
