Eight Mile Rd. between Klinger and Revere, in accordance with revised plans resubmitted to the Building Dept., on May 6th, 1953, whereby petitioner shall be permitted to have vehicles in the alley adjacent to said building serviced with gasoline.

Provided, Petitioner strictly com-

plies with requirement of the Fire Marshal, that there shall be only a responsible person in charge of the gasoline pump, and that an approved type fire extinguisher is always immediately available when gasoline is being dispensed, and that same shall be further maintained and conducted under the rules and regulations of the Fire Marshal, and the Dept. of Buildings & Safety Engineering; and further

Provided, That this resolution is revocable at the will, whim or caprice of the Common Council and also permits issued by virtue hereof, and grantee hereby expressly waives any right to claim damages or compensation from the City of Detroit for property constructed and maintained hereunder or for the removal of same, and further, that grantee acquires no implied or other privileges hereunder not expressly stated herein, and it is further stipulated that the grantee and their assigns hereby grant the Department of Buildings and Safety Engineering or its agents right of entry onto their property for the purpose of demolishing or removing such gasoline pump at any time that it may be so ordered by the Common Council, and they expressly waive any claim for damages arising from their acts in so entering their premises and removing said gasoline pump.
