Application for building permits to be subject to review by the Common Council only in the event a new use

of the property is requested.

II. All other Properties that the City plans to acquire: Application for building permits to be subject to review by the Common Council where the amount of the proposed construction is more than 15% of the total assessed value of the property at the time of the application.

The areas of the above controls are

shown on the attached map.

The City of Detroit does not intend to acquire private marinas as long as they remain in that use. Kean's Yacht Harbor, according to the abovementioned program, would therefore not be limited in the issuance of building permits unless the use of the property is changed, as indicated under Part I of this program. This apparently should satisfy petitioner's request.
