We are informed by their attorney that inasmuch as Charles M. Ziegler left office on July 1, 1957, and the deeds were dated July 25, 1957, it will be necessary that corrected deeds be issued to the successor.

We respectfully request that new deeds be issued to John C. Mackie, State Highway Commissioner of the State of Michigan. Further, that the description of Parcel A-62 be amended to read as follows:
