Honorable Common Council:
Gentlemen—Under date of August 14, 1956 your Honorable Body authorized and we entered into contract with S. C. & C. C. Trucking Corp. for Hauling Rubbish (File No. 5991, Contract No. 5969).

The contract provided for the addition or deletion of loading stations and dumping locations with prices to be determined on a mileage basis.

The S. C. and C. C. Trucking Corp. has recently been granted a permit to haul from the Southfield Station to the Detroit House of Correction, and we are requesting that the contract be amended to include this haul.

In determining the proper rate, we find that while the round trip mileage is less by 2.5 miles, that greater stand-by time and a shorter hauling day must be considered. The Department of Public Works, the City Controller, the Purchasing Department and the Contractor investigated these factors and agree that the contract base price is equitable.

We, therefore, recommend the following addition to the contract, effective immediately:

Hauling rubbish from the Southfield Station to the Detroit House of Correction dump — at a price of 45c per cubic yard.

The approval of your Honorable Body to this addition to the contract is requested.
