Whereas, the Congress of the United States, in the United States Highway Act of 1962, authorized relocation payments for families, individuals and businesses displaced by Federallyassisted highway construction when state law permits such payments; and,

Whereas, those affected by various types of governmental displacement are frequently least able to bear the financial burden imposed by this in-

State of Michigan do not permit relocation payments to those displaced

by highway construction;

Now, Therefore, Be It Resolved by the Common Council of the City of Detroit that the Legislature of the State of Michigan is urged to adopt such enabling legislation as may be necessary to permit relocation payments for moving expenses to be made to all families, individuals and businesses having to move because of any type of garagemental action any type of governmental action.

Gentlemen—We wish to advise that in carrying out the development plan for the Milwaukee Junction Project No. 1 which is being undertaken by the City of Detroit, it will be necessary to relocate Hendrie Avenue between Rivard and Russell Streets.

Your Honorable Body on July 25, 1961, J.C.C. Page 1541, adopted a resolution allocating land for Hendrie Avenue from Rivard to a point approximately 154 feet east of Rivard. This portion of relocated Hendrie Avenue was subsequently paved.

Due to the construction of the Walter P. Chrysler Expressway, it now becomes necessary to open and pave the remaining portion of Hendrie Avenue to Russell Street. This office has advised the City Engineer's Office to proceed with paving that portion of relocated Hendrie Avenue west of Russell Street. It will therefore be necessary for land to be allocated for the relocation of said portion of Hendrie Avenue west of Russell Street.
