## COMMUNICATIONS City Plan Commission April 9, 1965.

Honorable Common Council:

Gentlemen - Reference is made to petition No. 3903 of the Augustinian Fathers requesting a change in zoning from its present RM4 and R1 district classifications, property fronting on the north side of Mack Avenue between the existing B2 property located at the northwest corner of Mack and Canyon and the easterly line of lot 15, subdivision of P.C. 300, subject property having a depth of 202-24 feet.

At a hearing held before the Committee of the Whole, on December 11, 1964, to consider the above request, it was stipulated by Your Honorable Body that the rezoning of this property would not be appropriate unless the following conditions existed:

1. Petitioner were the owner of the adjacent property of George F. Con-

stantine.

2. The property could be served by a paved, commercial alley as described in the City Plan Commission report of October 21, 1964 to Your Honorable Body.

We have now received, and are forwarding to you, the following docu-ments furnished by petitioner, and approved as to form and accuracy by the offices of the City Engineer and the Corporation Counsel.

1. A copy of a warranty deed conveying to petitioner the adjacent property of George F. Constantine,

2. A quit claim deed conveying to the City of Detroit, for the purpose of an alley, the property as recommended in our report of October 21, 1964.

3. A bond to cover the cost of paveraged alley.
