The bids were taken on an evaluated basis, providing that the successful bidder would later enter into a three-year maintenance contract with the Department of Purchases and Supplies. The low bid, submitted by Fairbanks Morse, Inc. for the construction of the scale, in the amount of \$16,100, is regular in all respects and in accordance with the contract requirements. This firm has agreed to later enter into the maintenance contract at a total additional cost of \$2,610, based on the rate of \$145 for each of the 18 bi-monthly periods.
