Honorable Common Council:

Gentlemen-The development Plan for the University City Project No. 1, Mich. 12-53, approved and adopted by your Honorable Body on June 25, 1963, provides for the widening of Warren Avenue between Trumbull and the Lodge Freeway.

The land necessary for the widening was acquired as part of the project activities and is now owned by the City of Detroit, under the jurisdiction of

the Housing Commission.
It is our intention to transfer jurisdiction of this land from Housing to the Department of Public Works; the DPW will then transfer \$30,092.07 from their land acquisition account to the Temporary Loan Repayment Fund for this project. Subsequent to this transaction, the Wayne County Road Commission will commence the street widening construction.

The appropriate percentage of the amount expended by the DPW will be claimed as a non-cash local grant-inaid for this project and, as such, will make up a portion of the City's 1/3

share of the net project cost. The area of the land to be transferred is 85,977.36 square feet. The square foot price of \$.35 is the fair value for public or institutional land as determined by the re-use appraisal for this project.

We respectfully request adoption of the attached resolution providing for the transfer of jurisdiction as out-

lined above.

County Records;

3) All of Lots 1, 12 and 13, all that part of Lots 2, 11 and 14, all that part of the vacated alley adjoining Lots 2 and 11, of Avery and Murphy's Subdivision of Outlots 8 and 9, Lognon Farm and Outlots 100, 101, 104, 105 and the northerly 358.64 feet of Outlot 106 and the westerly 71.00 feet of Outlot 97, Woodbridge Farm, City of Detroit, Wayne County, Michigan as recorded in Liber 9, Page 42 of Plats Wayne County Records; and

Whereas, \$30,092.07 is not less than the fair value of the land described

above.
