Re: Wholesale Distribution Center Project No. 1, Mich. R-86 — Second Re-use Appraisal.

Gentlemen — In compliance with Federal regulations, we are now prepared to undertake a second re-use appraisal for the Wholesale Distribution Center No. 1 area. This appraisal, in combination with our previous first re-use appraisal will provide the price guidelines for sale of this land. Since the Eastern Market area is highly complex in its various uses and real estate transactions, it is very important to have someone undertake this appraisal who has thorough knowledge of this area.

Based on his experience in the Eastern Market section and his overall knowledge of the real estate market in and around this area, Mr. William P. Walsh has agreed to undertake this appraisal for a fee of \$3,500.00. The Detroit Housing Commission, at its meeting of February 2, 1967, authorized recommending Common Council approval of this work. Common Council authorization is therefore requested to enter into a re-use appraisal contract with Mr. William P. Walsh covering the Wholesale Distribution Center, Project No. 1, in the amount of \$3,500.00.
