whereby the City of Detroit and the
Michigan Highway Department
and mutually agreed jointly and mutually agreed cooperate in a comprehensive transportation planning process for the Six-County Area, made up of Macomb,

Oakland, Washtenaw, St. Clair, Mon-roes and Wayne counties.

At the same time an expenditure of \$63,000 was authorized to aid in financing Phase I of "Comprehensive Transportation and Land Use Program for the Detroit Region" detailed in or developed from the "Study Design" for the Program by the Detroit Metropolitan Area Regional Planning Commission dated October, 1964 a copy of which is on

file with the City Clerk.

The Transportation and Land Use Study, TALUS, has now prepared an allocation of costs for Phases II Phases through V totaling \$410,000., Detroit's share is \$68,019 distributed over three years as follows: 1966-67-\$34,690; 1967-68-\$22,446; and 1968-69 \$10,883.
