Gentlemen — Mr. David Sky of Sky Real Estate and Investment Company has offered as a gift to the City of Detroit property located in the Model Neighborhood area, between Woodward and Cass north of Myrtle, directly adjacent to the Earl Wick Park at 133 and 137 Davenport. Mr. Sky has also agreed to pay all 1972 outstanding taxes on the property.

The Depertment of Parks and Recreation has conferred with the Model Neighborhood Agency regarding this site, and on August 23, 1972 approved acceptance of the property as a gift. The Model Neighborhood Agency has agreed to assist the Department of Parks and Recreation in arranging for demolition of a burned-out structure on the property, and participating financially in development of the site.

The land would be useful for park purposes by extending the Earl Wick property to an alley at the westerly end of this site, and would act as a favorable neighborhood development relating to existing and proposed senior citizen housing in the immediate area.
