Honorable Common Council:

Gentlemen — On May 24, 1966, your Honorable Body passed a resolution opening Borman Avenue, 50 feet wide, from Southfield Road westerly through the Department of Public Works Southfield Yard to the Borman Food Stores, Incorporated, food processing plant.

The last section of that resolution provided for the relocation of this street to the northern edge of the DPW Yard whenever the construction of the Jeffries Freeway allowed. This street was to be constructed at no expense to Borman Food Stores.

The construction of this road, serving Borman Food Stores, has been completed along with a portion of the Jeffries Freeway Service Drive. The original roadway is being used, as planned, to service the Refuse Rehaul Station in the DPW Yard.

We, therefore, recommend the vacation of the original street and dedication of the new Borman Avenue to finalize the development of this area and submit the attached resolution for your consideration.
