Re: Ford Freeway (I-94); Reconstruction of shoulders, West City Limits to Livernois; Construction of Concrete Median Barrier, West City Limits to Warren; Agreement No. 73-0177.

This is in reference to an agreement between the Michigan State Highway Commission and the City of Detroit, which provides for the City's participation in the cost of reconstructing the outside shoulders on the Ford Freeway (I-94) from the West City Limits at Wyoming to Livernois and the construction of concrete median barrier and median shoulders from Wyoming to Warren.
