(2051), requesting permit to run oil pipe lines in alley south of and parallel to Rouge Ave., to its property immediately west of Oakwood Blvd. After consultation with the Department of Public Works, and careful consideration of the request, your committee recommends that same be granted in accordance with the following resolution.

By Councilman Dingeman:

Resolved, That the Department of Public Works be and it is hereby authorized and directed to issue permit to the Aurora Gasoline Company to run an 8 in. and a 6 in. oil pipe line, at least four feet underground, from a dock at and starting on the west line of River Rouge, on the north side of the alley south of and parallel to Rouge Avenue, then running westerly to the alley east of Oakwood Boulevard; thence northerly along the east side of alley parallel to Oakwood Boulevard, thence westerly along the south side of Rouge Avenue, across Oakwood Boulevard into petitioner's property immediately west of Oakwood Blvd.

Provided, Grantee shall furnish an approved security company bond in the sum of \$10,000.00, saving and protecting the City of Detroit harmless from any and all claims, damages or expenses by reason of the issuance of said permit and providing for the faithful performance by the grantee of the terms hereof, and files same with the City Controller, and further

Provided, That if the Commissioner of Public Works of the City of Detroit deems the amount of said bond inadequate at any time he may demand a bond in an amount which he believes will sufficiently protect the City's interests, and further

Provided, That grantee shall not

assign or transfer any right that it may have hereunder without the consent of the City of Detroit, and further

Provided, That said work shall be performed under the supervision of the Department of Public Works and in accordance with plans submitted to and approved by said Department.

Provided, That no rights in the public streets, alleys or other public places shall be considered waived by this permission, which is granted expressly on the condition that said oil pipe lines and all obstructions in connection therewith shall be removed at the expense of the grantee at any time when so directed by the Common Council, and that the public property affected shall be restored to a condition satisfactory to said Department by said grantee at its expense; and further

Provided, That said permit issued by the Department of Public Works is granted with the distinct understanding that in the event of the charter of the City of Detroit being amended in such manner as will provide for the levying of a fee, charge or rental, to be hereafter determined upon, or in the event of an ordinance or resolution being enacted providing for an annual charge or rental for the occupancy of public streets, alleys or other public places, that the grantee will pay said fee, charge or rental provided for in said charter or ordinance or resolution, and that said grantee does hereby bind himself thereunto and to accept said permit on the condition hereby imposed, and in the event of the said grantee contesting the validity of said charter amendment, ordinance or resolution or of said fee, charge or rental, or upon refusal to pay same, this permit shall immediately become void; and further

Provided, This resolution is revocable at the will, whim or caprice of the Common Council and grantee hereby expressly waives any right to claim damages or compensation for property constructed hereunder or for the removal of same, and further, that grantee acquires no implied or other privileges hereunder not expressly stated herein.
