Resolved, That the Dept. of Public Works be and it is hereby authorized and directed to issue permit to Edward Katulski and Julia M. Katulski, his wife, to install a marbellized front on two-story building on lots 37 and 38, Robert E. Walker's Sub., at 8725-31 Harper Avenue between Fischer and Crane Aves., to extend 1½ inches beyond the property line into Harper Ave., for a distance of 57 ft. width of the building, and maintain said encroachment for the life of the building.

Provided, That the work shall be performed under the supervision of the Dept. of Public Works and the Dept. of Buildings and Safety Engineering, and in accordance with plans submitted to and approved by those departments, and further

Provided, That at any time said building is remodeled, rebuilt or otherwise changed, it is placed on the proper lot lines with no encroachment on public property, and further

Provided, That this resolution is revocable at the will, whim or caprice of the Common Council and grantee hereby expressly waive any right to claim damages or compensation for property constructed and maintained hereunder or for the removal of same, and further that grantees acquire no implied or other privileges hereunder, not expressly stated herein.
