Resolved, That the Dept. of Public Works be and it is hereby authorized and directed to issue permit to National Bronze & Aluminum Castings Co., to install a 2 in. suction line, a 2 in. return line and a 2 in. vent line, under and across north/south public alley rear of 4460 Moran Ave. between Canfield and Garfield, to connect from underground fuel oil tank in said premises, crossing the alley at a point approx. 63 ft. south of the south line of Garfield Ave., to serve foundry building at 3520 Garfield, in accordance with grant of the Board of Zoning Appeals, Case No. 392-51.

Provided, Said lines are encased in concrete at least 3 ft. below top grade of the alley, and that said work shall be performed under the supervision of the Dept. of Public Works, and the Dept. of Buildings & Safety Engineering, and in accordance with plans submitted to and approved by said departments, and further

this permission, which is granted expressly on the condition that said utility lines and all obstructions in connection therewith shall be removed at the expense of the grantee at any time when so directed by the Common Council, and that the public property affected shall be restored to a condition satisfactory to said department by said grantee at its expense, and further

Provided, That said permit issued by the Department of Public Works is granted with the distinct understanding that in the event of the Charter of the City of Detroit being amended in such manner as will provide for the levying of a fee, charge or rental, to be hereafter determined upon, or in the event of an ordinance or resolution being enacted providing for an annual charge or rental for the occupancy of public streets, alleys or other public places, that the grantee will pay said fee, charge or rental provided for in said Charter, or ordinance or resolution, and that said grantee does hereby bind himself thereunto and to accept said permit on the conditions hereby imposed, and in the event of the said grantee contesting the validity of said Charter amendment, ordinance or resolution or of said fee, charge or rental, or upon refusal to pay same, this permit shall immediately become void, and further
