Resolved, That the Dept. of Public Works be and it is hereby authorized

and directed to issue permits described, to the following:

Wm. F. Back Lumber Co. (6027), to maintain a communication system line extending from premises at 11779 Cloverdale Ave., and crossing over Cloverdale Ave. at a point approximately 124 ft. south of the south property line of Elmhurst Ave., to petitioner's premises across said street. Provided, Same is maintained in accordance with plans submitted to and approved by the Public Lighting Commission, Dept. of Public Works, and Dept. of Buildings & Safety Engineering, and further, Provided, Petitioner furnishes a surety bond in the penal sum of \$5,000.00, saving and protecting the City of Detroit harmless from any and all claims, damages or expenses that may arise by reason of the issuance of said permit and providing for the faithful performance by the grantee of the terms hereof, and files same with the City Controller.

McLouth Steel Corp (5920), 300 S. Livernois, to install six, 4-in. cast iron conduits under and across Crawford Ave. from petitioner's factory on the east side of Crawford, to its premises on the west side of the street; said conduits being for one steam supply line, one steam tracer line, two oil lines, and an oil return line; the sixth line remaining vacant for future use. Provided, Said conduits are cased in concrete at least 3 ft. below the top grade of the street, and that the work shall be performed under the supervision of the Dept. of Public Works and the Dept. of Buildings & Safety Engineering, and in accordance with plans submitted to and approved by those departments, and further provided, that during such construction work, one half of Crawford Ave., shall be available for moving traffic at all times as recommended by the Dept. of Streets & Traffic.

Provided, That no rights in the public streets, alleys or other public places shall be considered waived by this permission, which is granted expressly on the condition that said utility lines and all obstructions in connection therewith shall be removed at the expense of the grantee at any time when so directed by the Common Council, and that the public property affected shall be restored to a condition satisfactory to said Department by said grantee at its expense, and further

Provided, That said permit issued by the Department of Public Works is granted with the distinct understanding that in the event of the Charter of the City of Detroit being amended in such manner as will provide for the levying of a fee, charge or rental, to be hereafter determined upon, or in the event of an ordinance or reso-

lution being enacted providing for an annual charge or rental for the occupancy of public streets, alleys or other public places, that the grantee will pay said fee, charge or rental provided for in said Charter, or ordinance or resolution, and that said grantee does hereby bind himself thereunto and to accept said permit on the conditions hereby imposed, and in the event of the said grantee contesting the validity of said Charter amendment, ordinance or resolution or of said fee, charge or rental, or upon refusal to pay same, this permit shall immediately become void, and further

Provided, This resolution is revocable at the will, whim or caprice of the Common Council and grantee hereby expressly waives any right to claim damages or compensation for property constructed hereunder or for the removal of same, and further, that grantee acquires no implied or other privileges hereunder not expressly stated herein.
