due to unfinanced budget adjustments or insufficient turnover to realize turnover cuts and also emergency overtime. These accounts can be financed in most instances by other appropriation or revenue surplus within the department.

The deficit of \$19,555 in Account 167-9090-150 Unused Sick Leave, was a result of this being a new item in the budget and there was a lack ZOO PARK (131) of past experience upon which to base this item in the budget. The 5120-121 Wages, \$283.52. deficit of \$31,100 in Sanitation wage
