Resolved, That the Dept. of Public Works be and it is hereby authorized and directed to issue permit to Griswold Building, Inc., (owner of premises herein described), to erect a metal vent duct at the rea of office building at 1230-32 Griswold St., described as Lots 72 and 73 and the N. 32 ft. of Lot 74, Sec. 8, Governor & Judges Plan; said duct to be 30 inches wide and to encroach 24 inches from the building over the alley beginning approximately 14 ft. above grade of the alley and to extend up to the roof of the building or approximately 121 ft. Provided, That same shall be con-

structed and maintained under the rules and regulations of the Dept. of Public Works and the Dept. of Buildings & Safety Engineering, in accordance with plane submitted to and approved by those departments, and

Provided, That the permittee, for itself, its successors, assigns and representatives shall accept such permit on the conditions hereby imposed, and with the further distinct under-standing that during the life of said encroachment the permittee will assume full liability for any and all damages which may be sustained by the City arising by reason of the granting of said permit, and that said permittee will, before the issuance of said permit, file with the City Controller a good and sufficient surety company bond in a company approved by him, in the amount of \$10,000.00, naming the City of Detroit as obligee therein, conditioned to indemnify and save harmless the City of Detroit from any and all loss or damage, including loss or damage emanating from personal injury and property damage, costs and expenses it may suffer arising during the life of said encroachment by reason of the issuance of said permit. The said bond shall be approved by the Corporation Counsel as to form and execution before filing same with the City Controller, and further

Provided, That the permittee shall acquire no implied or other privileges hereunder not expressly stated herein; that no rights in the public streets, alleys or other public property shall be considered waived by this permission, which is granted expressly on the condition that the encroachment hereby permitted shall be removed at the expense of the permittee at any time said structure or installation is remodeled, rebuilt or otherwise changed, so that the street, alley or other public property affected thereby shall remain free of such encroachment; and further

Provided, That said permit shall be issued only after a certified copy of this resolution has been duly recorded in the office of the Wayne County Register of Deeds, by and at the permittee's expense; and further

Provided, That this resolution is revocable at the will, whim or caprice of the Common Council, and that at any time said permit is revoked by the Council the said encroachment shall be removed by the permittee within the time directed, and that upon failure to do so, the Commissioner of the Department of Buildings & Safety Engineering or his agents may enter into and upon the premises and remove at permittee's expense, any part of said structure or installation which encroaches into or upon a street, alley or other public property, and further provided, that the permittee hereby waives any right to claim damages or compensation from the City of Detroit, or from any official agent thereof, due to the trespass or damage resulting from removing any such encroachment upon a street, alley, or other public property.
