Resolved, That the Dept. of Public Works be and it is hereby authorized and directed to issue permit to Coyle Sussex Medical Building, Inc. at 15121 W. McNichols, to install and maintain an approximate 10 ft. x 3 ft. sign supported by two wooden posts encroaching 8 in. into public property between the sidewalk and property line, subject to same being erected by a licensed and bonded sign erector, and further

Provided, That petitioner shall first furnish an Agreement saving and pro-tecting the City of Detroit harmless from any and all claims, damages or expenses that may arise by reason of the issuance of said permit, as required under Ordinance No. 224 - F, such agreement shall be submitted to the Corporation Counsel for approval, and filed with the City Controller; and further
