Resolved, That resolution adopted July 3, 1962 (J.C.C. p. 1606-7), granting petition of Jim Causley Pontiac, Inc. for the closing of E/W alley north of Mack Ave. and west of University Pl., and that portion of the N/S alley extending southerly from the E/W alley and adjacent to the petitioner's property on a temporary basis for a period not exceeding three years from July 3, 1962, be and the same is hereby amended for the purpose of making an exception to Paragraph 3 which provides that no building or other structure is constructed in said alleys. Such exception being to permit Jim Causley Pontiac, Inc. to con-struct an extension to its present building at said location, known as 17677 Mack Ave., to encroach beyond the property line for a distance of not more than 5 ft. into the said N/S alley and maintain same only for the remaining period of three years from July 3, 1962, to coincide with the resolution that is herein amended, subject to petitioner securing a permit for such encroachment from the Department of Public Works, which department is hereby authorized and directed to issue same, provided petitioner shall first furnish an amendment to the liability agreement which was furnished pursuant to said resolution of July 3, 1963. Such amended agreement being for the purpose of saving and protecting the City of Detroit harmless from any and all claims, damages and expenses that may arise by reason of the issuance of the encroachment permit herein granted, which amended agreement shall be first approved by Corporation Counsel and filed with the City Controller, and further subject to the work being performed in accordance with approved building plans for special footings to be constructed so that safety be provided for the public sewer under said alley, and that said work shall be performed under the rules and regulations of the Departments of Public Works and Buildings

in; that no rights in the public streets, alleys or other public property shall be considered waived by this permission, which is granted expressly on the condition that the encroachment hereby permitted shall be removed at the expense of the permittee immediately at the expiration of said period, so that the street alley or other public property affected thereby shall remain free of such en-
