resolution; therefore, be it

Resolved, That the Department of Public Works be and it is hereby authorized and directed to issue permit to ITT Abrasive Products Co. to maintain a macotta facing on the front of existing two-story factory building at 729 Meldrum Ave. between Meldrum and Beaufait, described as the S. 32 ft. of Lot No. 42, Sub. of Part of Meldrum and Beaufait, etc., encroaching 11/2 in, beyond the property line into Meldrum Ave. for a distance of approximately 32 ft., width of the building.
