Resolved, That resolution adopted May 2, 1972, J.C.C. pages 1023-24, granting petition No. 4343 of North Detroit General Hospital for a pedestrian bridge across McDougall between Carpenter and Halleck Avenues, be and the same is hereby amended for the purpose of including installation of oxygen and steam lines in two streets and a public alley, in

accordance with the following new resolution, Therefore, Be It Hereby Resolved, That the Departments of Public Works and Buildings and Safety Engineering be and they are hereby authorized and directed to issue permits to North Detroit General Hospital, a Michigan Corporation, to install oxygen and steam lines in two streets and a

public alley. Encroachments consist of the

following installations:
A 1-1/4" oxygen line commencing east of the east property line of Charest and proceeding west across Charest and into the public alley first North of Carpenter and then across McDougall and then south into the new addition; and
A 6" steam line and a 3" return line

to be in the public alley west of Charest and continuing to a point west of McDougall approximately 100 feet and then south into the

building.

Provided, That the necessary permits be obtained from the Department of Public Works and the Department of Buildings and Safety Begineering and that the work shall be constructed and maintained under

their rules and regulations, and the Fire Marshall, and in accordance with plans submitted to and approved by

them, and

That permittee Provided, time of obtaining said permits file a Rider to the \$25,000.00 Indemnity Bond now on file with the City Controller, approved by the Corporation Counsel, saving and protecting the City of Detroit harmless from any and all claims, damages or expenses that may arise by reason of the issuance of said permits and the faithful performance by the permittee of the terms thereof, and in addition, to pay all claims, damages or expenses that may arise out of the maintenance of said permission; and Provided, That the lines be installed

at a minimum of thirty (30") inches beneath the grade of the public alley;

and

Provided, That permittee obtain necessary utility clearance prior to

the issuance of any permits, and Provided, That said fuel and exygen lines be maintained and operated at

the sole cost of the permittee; and Provided, That no rights in the public streets, alleys or other public places shall be considered waived by this permission, which is granted expressly on the condition that said lines and all obstructions in connection therewith shall be removed at the expense of the permittee at any time when so directed by the Common Council, and that the public property affected shall be restored to a condition satisfactory to said departments by said permittee at its expense; and

Provided, That this resolution is revocable at the will, whim or caprice of the Common Council and permittee hereby expressly waives any right to claim damages or compensation for property constructed hereunder or for the removal of same, and further, that permittee acquires no implied or other privileges hereunder not expressly stated herein; and

Provided, That these permits shall not be assigned or transferred without the written approval of the Common Council; and

Provided, That the filing of the Rider to the Bond now on file with the City Controller and the securing of the necessary permits referred to herein shall be construed as acceptance of the terms of this

resolution by the permittee; and
Provided, That a certified copy of
this resolution shall be recorded with the office of the Register of Deeds for Wayne County by and at permittee's expense.
