inclu. of Plats, WCR; the south 24 feet of Lot 11, the south 68 feet of Lot 7 and the east 10 feet of the south 68 feet of lot 8 of the above named plat."

The encroachments consist of the

following:

1. Two triangular protruding windows, one each on the third story of the north and south brick walls. The window on the south elevation will protrude a distance of 4½ feet onto the public alley some 20 feet above the present alley grade.

2. Buff colored sidewalks along the

west side of St. Antoine south of east Lafayete for a distance of 68 feet and for a width of ten feet; also for a distance of 162 feet along the south side of East Lafayete west of St. Antoine for a width of 15 feet.
