Resolved, That the Department of Public Works be and it is hereby authorized and directed to issue permits to Mr. Mike Ramirez to construct two concrete steps in the berm area adjacent to a "Handicapped Parking" place in front of 4219 Brandon.

Property known as: Lot 266, Scotten and Lovett's Resubdivision of all that part of P.C. 583 lying north of the Dix Road and south of the M.C.R.R., Springwells (now Detroit), Wayne County, Michigan, as recorded in Liber 5, Page 42, Plats, Wayne County records;

Provided, That said permit shall be issued only after a certified copy of this resolution has been duly recorded by and at the permittee's expense in the Office of the Register of Deeds for Wayne County; and further

Provided, That no right in the public street shall be considered waived by this permission which is granted expressly on the condition that the steps and all obstruction in connection therewith shall be removed at the expense of the grantee at any time when so directed by the City Council; and further

Provided, If at any time in the future it becomes necessary to repair or replace the sewers or other utilities located or to be located in said street, by the acceptance of this permission, the owners for themselves, their heirs and assigns, waive claims for any damages to the encroaching installations and agree to pay the costs incurred in their removal, if their removal becomes necessary, and to restore the property affected to a condition satisfactory to the Department of Public Works at the owners' expense; and further

Provided, That this resolution is revocable at the will, whim or caprice of the Common Council, and the grantees by the acceptance of this permission waive any right to claim damages or compensation for any driveways or structures constructed and maintained hereunder, or for removal of the same, and they acquire no implied nor any other privileges not expressly stated herein.
