Re: Temple/Second Avenue Street Improvements, EDA Title I.

On June 8, 1983 (J.C.C. Pg. 1076-77), Your Honorable Body authorized Mayor Coleman A. Young to submit an Economic Development Administration (EDA) Title I grant application of \$800,-000 for the Temple/Second Avenue Street Improvements project. A local match of \$270,000 from the Cass/Woodward Corridor bond money was pledged for the requested EDA grant. Further, Your Honorable Body's action authorized acceptance of the EDA grant should such an award be tendered. The EDA grant was awarded to the City of Detroit on September 30, 1983 for \$856,000, and the local match now required is only \$214,000.

It is, therefore, requested that Your Honorable Body authorize the Finance Director to establish the necessary appropriation and honor vouchers when submitted in accordance with the grant

agreement.

Re: Temple/Second Avenue Street Improvements Petition by C&EDD Requesting Approval to Install trees, Decorative Paving and Other Amenities in Full Width Sidewalks in the Project Area.

On June 8, 1983 (J.C.C. pp. 1076-77). Your Honorable Body authorized Mayor Coleman A. Young to submit an Economic Development Administrative (EDA) grant application for the Temple/Second Avenue Street Improvements project. Further, Your Honorable Body's action authorized acceptance of the EDA grant should such an award be tendered. The EDA grant was awarded to the City of Detroit on September 30, 1983.

This grant is to be used in the improvement and beautification of Temple Avenue and other streets which lead to and surround the Metropolitan Center for High Technology.

This design plan provides for new sidewalk and streets, tree planting and other planting material, with some decorative sidewalk treatment, benches. lighting, and signage.

Under Ordinance 415-F, Part I (Detroit City Code 58-3-10) City Council approval of the proposed treatment for the sidewalk areas is required under the provisions of this ordinance.

The preliminary design plans for the project have been reviewed and approved by all concerned City Departments, public utilities and Community Organizations. Community and Economic Development Department hereby petitions Your Honorable Body for approval to execute these improvements within the Sidewalk areas. A resolution for your consideration is attached herewith.
