Returning herewith Petition No. 3903 of Comprehensive Health Services of Detroit, Inc. requesting permission to install computer and telephone cable beneath West Grand Boulevard between buildings addressed as 2875 and 2894 West Grand Boulevard.

Cable placement will require augering (minimum depth 42 inches) or saw cutting, trenching, and pavement replacement. Necessary permits for this street opening will have to be obtained from the City Engineering Department, the Water and Sewerage Department and the Recreation Department.

The Water and Sewerage Department will require a minimum vertical clearance of one foot between their sewers, drains, water mains and any cable crossing the mains. Also, a minimum horizontal clearance of three and one-half feet is required between the proposed construction and fire hydrants, catch basins, sewer and water manholes and other Water and Sewerage Department facilities.

The Recreation Department will require the petitioner avoid center island damage to landscape materials, sprinkler lines and other department facilities. Additionally, observation of construction activity by Recreation Department staff at the petitioner's expense may be required.

All other involved City departments and privately owned utility companies have replied they have no objection to this proposal provided care and caution are used in the augering or street opening to cross their properties. They have also requested the petitioner make use of the "Miss Dig" facilities before construction and then become a participating member of that organization. This will minimize the chance of future damage to the petitioner's property.

An appropriate resolution, granting the petition, is attached for consideration by your Honorable Body.

Re: Business sign in PCA (Restricted Central Business District) zone at 422 West Congress (Recommend Approval).

The Arrow Sign Company is proposing to erect signage for a new restaurant known as "Ricky's" to be located in an existing building at 422 West Congress, which is on the north side of Congress between Cass and First. This building is in a PCA zoning district, and therefore City Council approval for signage must be obtained after receipt of a written recommendation from the Planning Commission. The Commission has delegated to staff the authority to recommend approval or disapproval of signs in a PCA zone.

The proposed signage would consist of one wall sign 26.5 feet long and 2 feet high with a logo measuring 8 feet by 5.5 feet, as shown in the attached illustration. Re: Proposed amendments to the Zoning Ordinance to require a yearly inspection of locations receiving special land use grants and variances (Recommend Approval).

Submitted herewith is the City Planning Commission's report and recommendation on the above-captioned proposed Zoning Ordinance amendments. The proposed ordinance would require a yearly inspection of all locations receiving special land use grants (Permitted with Approval Uses, Regulated Uses and Controlled Uses) and variances (dimensional and use variances).

The proposed amendments are the result of the City Planning Commission's concern about the problem of enforcing the conditions placed on these

grants throughout the city. It has come to the attention of the City Planning Commission that enforcement is a major problem with regards to zoning in the City of Detroit. Enforcement of the Zoning Ordinance is the responsibility of the Buildings and Safety Engineering Department, but the Department needs the proper tools to perform the job. The Buildings and Safety Engineering Department is currently researching the feasibility of instituting a ticketing system for zoning violations. The system has worked well in several other cities, but will take several years to institute if it is deemed appropriate for Detroit. The B&SE Department is also working with the courts in an attempt to improve zoning compliance. The City Planning Commision has had discussions on this problem which have included City Departments and staff. It has been concluded that a yearly inspection of special land use grants and variances is needed along with the other remedies that are being
