The Police Department has requested permission to encroach into the public street rights-of-way of Plymouth and Fitzpatrick Avenues at 11450 Warwick Avenue in order to construct the new Sixth Precinct station. The construction of the new Police station was assigned to the Detroit Building Authority (Contract D.B.A. - 26).
