**Proposals for City Bonds.**

Sealed proposals will be received at this office until Monday, September 13, 1886, at 10 o'clock a. m., for the purchase of one hundred thousand dollars of public sewer bonds of the city of Detroit; said bonds will be of the denomination of one thousand dollars each, dated October 1, 1886, and payable twenty years thereafter, with semi-annual interest at the rate of three and one-half (3½) per cent per annum, principal and interest payable in the city of New York.

Before any ballot is placed thereon the Board of Public Works shall have the right and privilege of rolling the road bed with the steam road roller owned by the city, and each block of the street shall be kept clear and ample time be allowed for that purpose.
