Controller submitting his bids for taking care of the Eastern Market, respectfully report that upon examination we find that under the specifications bids were called for at rate per month, there being a bid required for the old part of the Eastern Market and one for the new part. The specifications also stated that the successful bidder for the new part should not commence work until directed to do so by the Controller. The lowest bidder was Jos. Hilmer, who offered to do the work for \$250 per year for the old market and \$110 for the addition for the year for the Eastern Market. This was at the rate on the old market of \$20 83 per month as against \$22 00, the next lowest bid. His bid on the new part was at the rate of \$9 16, as against \$18 00 for the next lowest bid. We therefore recommend that the Controller enter into a contract with Jos. Hilmer at the rate of \$20 83 per month for the old, and \$9 16 for the new, the contract specifying that the pay does not commence on the new part until the Controller shall instruct the contractor to commence work, and we herewith offer the following resolution.
