Ordinance.

The following was offered by Ald. Moeller:

AN ORDINANCE to amend Section 22 of Chapter 97, of the Revised Ordinances of 1895.

It is hereby ordained by the people of the city of Detroit:

Section 1. That Section 22 of Chapter 97, of the Revised Ordinances of the city of Detroit of 1895, be and the same is hereby amended so as to read as follows:

Sec. 22. No person shall sell or offer for sale in the public markets, or anywhere in the city of Detroit, any fruit, vegetables or berries, in baskets, crates or other measures, at or for a greater weight or measure than the true weight or measure thereof, or in baskets or measures of less capacity than the usual size and capacity of baskets or measures established by the standard of dry measure; and all meats, poultry and provisions, excepting vegetables sold by the head or bunch, of every kind sold in the public markets, or elsewhere in said city.

18 shall be weighed or measured by
19 scales, weights or patent balances,
20 or in measures or patent balances,
21 stamped by the City Inspector and
22 Weights and Measures; Provided,
23 That poultry may be offered for
24 sale and sold in other manner
25 than by weight; but in all cases
26 where the party intending to pur-
27 chase shall so desire and request,
28 poultry shall be weighed as here-
29 inbefore provided.

Sec. 2. This ordinance shall take immediate effect.

Read twice by title, ordered printed and referred to the Committee on Ordinances.
