In Memoriam.

On the 20th day of July, A. D. 1904, at the city of Yonkers, in the state of New York, William Galion Thompson thereof his body was laid at rest with kindred in the family lot in old Princeton Cemetery at Princeton, in the state of New Jersey.

Mr. Thompson's services to his country covered eras of peace and war. His

Mr. Thompson's services to his country covered eras of peace and war. His first service was in the war of the rebellion, where he won distinction by first service was in the war of the rebellion, where he won distinction by distinguished bravery in action and between the wounds of his honorable service. Mr. Thompson served the city of Detroit as a member of the Common Councils of 1874 Ward of the city. Subsequently he was elected Mayor of Detroit, serving most acceptably in that office for four years, expiring January, 1884 Mr. Thompson also served his State as Senator for the Second District in the Legislature of 1895.

His official life in all his varied services was marked by singular probity of character and action. It is universally conceded that a more careful and conscientious public servant has seldom served the people. His first thought and high aim seemed to be that no stain occurring through act of commission or omission should affect the high call which brought him into public service.
