**Street Openings.**

To the Honorable the Common Council:  
Gentlemen—To your Committee on Street Openings was referred the petition of Samaritan Hospital (1384), for the vacation of alley first north of and parallel with Milwaukee ave., extending easterly from East Grand Boulevard. The alley in question was vacated October 16, 1917 (J. C. C. p. 1380-1), on petition of John H. Neary, on condition that certain property be deeded to the city for alley purposes within 30 days. Owing to inability of petitioner to comply with this condition, a new petition is presented. Your Committee therefore recommends that an extension of time within which petitioner may present deed of said property, be granted for a period of 90 days from November 16, 1917, the limit specified in said resolution for submitting same, and therefore offer the following resolution.

Whereas, All that part of the public alley, 12 feet wide, first north of and parallel to Milwaukee avenue and lying between the east line of East Grand Boulevard and the west line of the East 24 feet of lot 18, E. D. Foster's sub. of part of lot 11, fractional sections 29 and 32, etc., was vacated October 16, 1917 (J. C. C. p. 1381), provided that the East 12 feet of the north 78 feet and the east 24 feet of the south 12 feet of lot 18, subdivision last mentioned, was deeded by

petitioner to the City of Detroit for alley purposes, within 30 days from date of resolution; and

**Street Openings.**

To the Honorable the Common Council:  
Gentlemen—To your Committee on Street Openings was referred the petition of Chas. J. Merbach, et al. (1225½), for the widening of alley extending from Woodward Ave. to John R. Street, south of Watson Street. Your Committee have had the same under consideration, have complied with Rule 22, and find that the alley requested to be widened is 10 feet in width, extending westerly from John R. Street to Lot M, Parson's Estate Sub., with a turn-around. Your Committee recommends, in lieu of widening said alley by condemnation proceedings, that a part of said alley be vacated, being a portion of the turn-around referred to, provided the owners of Lot 3, Plat of Brush sub., abutting existing alley on the south, dedicate to the City of Detroit for alley purposes, a strip of land 7 feet in width, and further provided the owner of Lot B deeds a strip of land 10 feet in width.
