AN ORDINANCE to regulate the running time and operation of street cars upon Woodward Avenue north of the Log Cabin to the Eight-Mile Road, and to fix a penalty for the

Road, and to fix a penalty for the violation thereof.

IT IS HEREBY ORDAINED BY THE PEOPLE OF THE CITY OF DETROIT.

Sec. 1. That the Detroit United Railway, a corporation, its officers, agents and employees shall cause the running time of all street cars operated by it on week days before tween the hours of 5:30 o'clock in the evening on Woodwa. Avenue beyween the Log Cabin, so-called, and the Eight-Mile Road shall be service upon such line, or, as much oftener as the traffic between said points may demand and require for the accommodation of passengers, points may demand and require for the accommodation of passengers, and thereafter the running time between said points shall be suf-ficient to accommodate the pass-enger traffic thereon. Sec. 2. It is hereby declared that the public convenience requires that street cars shall be operated as

the public convenience requires that street cars shall be operated as provided in this Ordinance.

Sec. 3. Any violation of or failure to comply with the provisions of this ordinance, shall, upon conviction thereof, be punishable sions of this ordinance, shall, upon conviction thereof, be punishable by a fine of not to exceed five hundred (\$500.00) dollars, or imprisonment within the Detroit House of Correction for a period of not to exceed ninety (90) days, or both such fine and imprisonment within the discretion of the Court. Each day during which any violation of 12 day during which any violation of 13 of the terms hereof occurs shall be 14 considered to be a separate offense 15 and shall be punishable as such.
