To the Honorable the Common Council: Gentlemen—To your Committee of the Whole was presented a communication from the Corporation Counsel with reference to the protest of Mr. Clarence M. Burton et al against the resolution adopted by the former Common Council of the City of Detroit July 31st, 1917 (J. C. C. page 1000), vacating part of public alley 20 feet wide first west of and parallel to Woodward avenue, lying between the north line of Chicago Boulevard west and a point 109.50 feet north thereof and rendering an opinion, as requested, as to whether your Honorable Body could legally rescind such action.

Your Committee, after a thorough consideration of same, recommend that the communication be received and placed on file.
