Lease Library Grounds

To the Honorable the Common Council:
Gentlemen—To your Committee of the Whole was referred a lease between the City of Detroit and the Detroit Library Commission and the Board of Education of the City of Detroit, for the leasing of certain lands situated in the City of Detroit, County of Wayne, State of Michigan, described as follows:

That certain triangular parcel of ground in Section 7 of the Governor and Judge's Plan of the City of Detroit, heretofore and sometimes called Centre Park, and bounded by Gratiot, Farmer and Library (formerly Farrar) streets, said ground having been, on the 17th day of May, 1872, by an ordinance of the Common Council of the City of Detroit, vacated as a public space.
