Gentlemen—Your Committee of the Whole begs to report that it has again had under consideration the petition of Dennis Griffin, et al (6819), for the opening of the east and west alley in block bounded by Sixth, Brooklyn, Hinkley and Selden avenues, also the petitions of Ellen Morton (7153), protesting against said opening and of Martin Knorr (7154), requesting removal of his name from petition for the opening. After a further consideration of the matter and a personal inspection of the alley, we recommend that the report of the Committee of the Whole directing the Corporation Counsel to prepare resolution for the opening of alley first south of and parallel with Selden Avenue, between Sixth and Brooklyn Avenues, where not already open, adopted May 22, 1923 (J.
