To The Honorable the Common Council:

Gentlemen—The Board of Education at a meeting held May 28th last authorized the Business Manager to petition your Honorable Body to vacate the following described property now used for alley purposes at the Chandler School site:

All of Public Alley 18 ft. in width lying between the easterly line of Belvidere Avenue and the westerly line of McClellan Avenue and adjoining the southerly line of Lot 70 of McCormack's McClellan Avenue Subdivision of part of Private Claims 10 and 152 as recorded in Liber 19, page 31, of Plats of Wayne County Records and the southerly line of Lot 119 of Joseph S. Visger's Gratiot Avenue Subdivision of part of Private Claim 10, south of Gratiot Avenue as recorded in Liber 18, page 84, of Plats of Wayne County Records, also to vacate all of public alley 18 ft. in width, lying easterly of the easterly line of Lots 119 to 125, both inclusive, and the southerly 12 ft. of Lot 126 of last mentioned Subdivision.

The Board further authorized that in lieu of the land vacated, the Board to dedicate to the City of Detroit land to be used for alley purposes, described as:

The northerly 18 ft. of Lot 63 of McCormack's McClellan Avenue Subdivision, heretofore mentioned, also the northerly 18 ft. of Lot 126 of Joseph S. Visger's Gratiot Avenue Subdivision, heretofore mentioned.

To the Honorable the Common Council:

Gentlemen—We have a communication from the City Engineer's Office stating that a petition has been presented for the paving of the alley in the block bounded by 28th, Lovett, Herbert and Warren Avenues; stating further that the alley is in such a condition that it would be unwise to pave it without proceedings being taken for the straightening of the lines. The present alley is 10 feet wide at one point, 18 feet at another, and over 20 feet at still another point.

In order that the alley may be paved, we recommend that said alley be widened to a uniform width of 18 feet, as is shown on the accompanying blueprint. We further recommend that such portions of the alley as are not needed be vacated to the adjoining property owners in order that the alley can be of uniform width throughout. (Plan No. 310-30.)

To the Honorable the Common Council:

Gentlemen—The City Plan Commission has considered the petition of Catherine Green et al (6807), referred to us by your Honorable Body, requesting that the alley be opened in the rear of Grand River Avenue on the north side between the easterly side of Lot 1260, B. E. Taylor's Subdivision No. 4, and Whitcomb Avenue as ordered opened.

We find that the existing alley has no outlet, and as unsubdivided property only will be affected, the City Plan Commission recommends that the petition be granted, and that the alley be opened and widened as is shown on accompanying blueprint, Plan No. 310-28, the proceedings to take place after Whitcomb Avenue has been opened.
