

**Vacation of Strip of Land**

To the Honorable, the Common Council:

Gentlemen—To your Committee of the Whole was referred petition of O. G. Shoup (11028), to be permitted to pay the sum of \$175.00 for strip of land at the northwest corner of Begole and Milford Aves., vacated by resolution adopted July 14, 1914 (J. C. C., p. 1091). Your committee finds that this strip of land was vacated on above-mentioned date, but through error on the part of petitioner's agent the sale was never completed.
