Resolved, That "all of the public alley, 18 feet wide, adjoining the southerly line of the westerly 73.24 ft. of lot 24 of Mulberry Hill Sub. of the S. ½ of the S. ½ of the S. E. ¼ of Section 16, T. 1 S., R. 11 E., as recorded in Liber 33, page 63 of Plats of Wayne County Records," be and the same is hereby vacated to become a

part and parcel of the adjoining property.

Provided, Petitioner deeds to the City of Detroit for street purposes "the easterly part of lots 21 to 24, both inclusive, of last mentioned subdivision, being 26.76 ft. on the southerly line of lot 24 and 26.80 ft. on the northerly line of lot 21," and further

Provided, Petitioner reimburses the owners to the extent of the value of any utilities now installed in said alley which it may be necessary to abandon, due to the closing of same, or bears the entire expense of same, including or rerouting any public utilities now installed in said alley, which it may be necessary to relocate or route due to the closing of same, and further

Provided, That by reason of the vacation of the above described alley the City of Detroit does not waive any rights in the lateral sewer located in alley aforesaid and shall at all times have the right to enter upon the premises if found necessary on account of said sewer to repair same, and provided further that petitioner shall not build over the above described alley without first securing the approval of the City Engineer and the Board of Health, and further

Resolved, That the City Controller be and is hereby directed to execute quit claim deed covering the property herein vacated.
