Councilman Kronk then moved that the motion to reconsider be indefinitely postponed, which motion prevailed.

The regular order was resumed.

From the Department of Public Welfare

To the Honorable, the Common Council:

Gentlemen-At the suggestion of the City Engineer's office, the Public Welfare Commission has authorized this bureau to request your Honorable Body to vacate two alleys on Western Municipal Market, described as follows:

"All of public alley 20 feet wide lying in the rear of lots 15 to 25, both inclusive, of Weitzel's Plat of the Subdivision of part of Private Claim 338 as recorded in Liber 1, Page 204, of Plats of Wayne County Records, and also lying in the rear of Lots 116 to 125, both inclusive, of Bradish and Hubbard's Subdivision of part of the Loranger Farm, being a section of Private Claim No. 474 and the westerly 1/9 of Private Claim No. 338 north of Michigan Ave. as recorded in Liber 1, page 133, of Plats of Wayne County Records." "Also all of the public alley 20 feet

wide adjoining the southerly line of Lot 6 of the Weitzel's Plat hertofore mentioned, being that portion of said Alley lying between the extension southerly of the easterly and westerly

line of said Lot 6."

In lieu of the vacation of these alleys, which are entirely within the Western Market site and of no value to the public, the Public Welfare Commission further authorizes this bureau to request that you set aside for the use of the public as an outlet for the alley north of and parallel to Michigan Ave., a portion of Western Market site described as:

'The westerly 20 feet of Lot 1 of Bradish and Hubbard's Subdivision heretofore mentioned and the northwesterly portion of Lot 5 of Weitzel's Plat heretofore mentioned, being that part of said Lot 5 lying within a line drawn 20 feet easterly of and parallel to the westerly line of said Lot 1 of Bradish and Hubbard's Subdivision."

The above described outlet is now in use as an alley and would not reduce the effective size of the Mar-

Be and the same are hereby vacated to become a part and parcel of the adjoining property, and further Resolved, That "the westerly 20 ft.

of lot 1 of Bradish & Hubbard's Subdivision heretofore mentioned, and the northwesterly portion of lot 5 of Weitzel's Plat heretofore mentioned, being that part of said lot 5 lying within a line drawn 20 ft. easterly of and parallel to the westerly line of said lot 1 of Bradish & Hubbard's Subdivision," be and the same is hereby set aside to be used for alley purposes.

Provided, That by reason of the vacation of the above described alleys the City of Detroit does not waive any right in the lateral sewers located therein, and shall at all times have the right to enter upon the premises if found necessary on account of said sewer to repair same, and further provided, that the Bureau of Markets shall not build over the above described alleys without first securing the approval of the City Engineer

and the Board of Health.
