Vacation of Tractor Ave.

To the Honorable, the Common Council:

Gentlemen—To your Committee of the Whole was referred petition of the Pennsylvania, Ohio & Detroit Railroad Co. (6329), requesting the vacation of a portion of Tractor ave. between Greyfriars ave. and the Wabash R. R. Your committee is advised by the City Plan Commission that this street comes to a dead-end at the railroad, that this section of the street has never been used for street purposes, and petitioners are the owners of all property abutting upon the portion to be vacated. After careful consideration of the request, your committee recommends that the petition be granted provided a 20 foot alley outlet is deeded to Greyfriars avenue, and we therefore offer the following resolution.

W. 58.48 feet to a point; thence along a line N. 29 deg. 08 min. E. 25.00 ft. to a point; thence along a line S. 60 deg. 52 min. E. 40.58 ft. to a point; thence along a line N. 29 deg. 08 min. E. 25 ft. to a point on the southwesterly line of lot 176 of said subdivision; thence along said lot line S. 60 deg. 52 min.
