Resolved, That "all that part of Manor Avenue lying between Margareta and Clarita Avenues and the north and south public alleys lying 1st east and 1st west of Manor Avenue between Margareta and Clarita Avenues more particularly described as all that part of Manor Avenue, 60 feet wide, lying between the easterly line of the northerly 35 feet of Lot 45, the easterly line of Lots 46 to 58 both inclusive, the easterly line of the southerly 30.68 feet of Lot 59 and the westerly line of the southerly 37.01 of Lot 30, the westerly line of Lots 31 to 43 both inclusive, the westerly line of the northerly 35 feet of Lot 44 all in Marygrove Manor, a subdivision of part of the W. 1/2 of the N. W. 1/4 of the N. E. 1/4 of Section 8, T. 1 S., R. 11 E., City of Detroit, Wayne Co., Michigan, as recorded in Liber 61, Page 67, of Plats of Wayne County Records."

Also "all of the north and south public alley 20 feet wide lying between the easterly line of the southerly 16.6 feet of Lot 94, the easterly line of Lots 95 to 122 both inclusive, the easterly line of the northerly 17.5 feet of Lot 123 and the westerly line of the northerly 35 feet of Lot 45, the westerly line of Lots 46 to 58 both inclusive, the westerly line of the southerly 30.68 feet of Lot 59 all of last mentioned Subdivision.

Also all of north and south public alley 9 feet wide lying easterly of and adjoining the easterly line of the southerly 35.86 feet of Lot 30, the easterly line of Lots 31 to 43 both inclusive, the easterly line of the northerly 35 feet of Lot 44 all of last mentioned Subdivision," be and the same are hereby vacated to become part and parcel of the adjoining property

Provided, Owners in Fee deed to the City of Detroit, "the northerly 10 feet of Lots 30, 59 and 94 of Marygrove Manor, a Subdivision of part of the W. 1/2 of the N. W. 1/4 of the N. E. 1/4 of Section 8, T. 1 S., R. 11 E., City of Detroit, Wayne Co., Michigan, as recorded in Liber 61, page 67, of Plats of Wayne County Records," to be used for street purposes and known as Clarita Avenue.

Also "the southerly 10 feet of Lots 44, 45 and 123 of last mentioned Subdivision," to be used for street purposes and known as Margareta Avenue.

Also "all that part of the northwest 1/4 of the Northeast 1/4 of Section 8, T. 1 S., R. 11 E., more particularly described as Beginning at the southeasterly corner of Marygrove Manor Subdivision heretofore mentioned; thence along the easterly line of said Subdivision North 0 Degrees 04 Minutes West 35 feet to a point; thence along a line North 89 Degrees 47 Min-

utes 50 Seconds East 75.51 feet to a point; thence along a line South 0 Degrees 29 Minutes East 35 feet to a point in the northerly line of Margareta Avenue. 25 feet wide as now established; thence along said northerly line South 89 Degrees 47 Minutes 50 Seconds West 75.76 feet to the place of beginning," to be used for street purposes and known as Margareta Avenue.

Also "all that part of the northwest  $\frac{1}{4}$  of the Northeast  $\frac{1}{4}$  of Section 8, T. 1 S., R. 11 E., more particularly described as Beginning at a point in the easterly line of Marygrove Manor Subdivision heretofore mentioned, said point being the intersection of the northerly line of Clarita Avenue, 50 feet wide, as now established extended easterly with the easterly line of said Marygrove Manor Subdivision; thence along said northerly line of Clarita Avenue extended easterly South 83 Degrees 40 Minutes 55 Seconds East 70.76 feet to a point; thence along a line South 0 Degrees 29 Minutes East 60 feet to a point; thence along a line North 89 Degrees 40 Minutes 55 Seconds West 71.2 feet to a point in the easterly line of said Marygrove Manor Subdivision; thence along said easterly line North 0 Degrees 04 Minutes West 60 feet to the place of beginning," to be used for street purposes and known as Clarita Avenue, and further

Provided, That petitioners reimburse the owners to the extent of the value of any utilities now installed in said alleys and street which it may be necessary to abandon due to the closing of said street and alleys or bear the entire expense of relocating or rerouting any public utilities installed in said street and alleys which it may be necessary to relocate or reroute due to the closing of said street and alleys, and further

Provided, That if at any time in the future the petitioners are able to acquire title to the property lying between the present easterly line of their property and the westerly line of Monte Vista Avenue, 30 feet wide, as now established, they will dedicate to the City of Detroit, the land for the widening of Monte Vista Avenue to a width of 60 feet between Clarita and Margareta Avenues and for the widening and/or opening of Clarita and Margareta Avenues to 60 foot widths west of Monte Vista Avenue, and further.

Provided, All taxes on petitioner's property adjoining vacated and dedicated streets and alleys be paid in full and further,

Resolved, That upon compliance with the provisions of this resolution the city Controller be and is hereby directed to issue quit claim deeds

covering property herein vacated to owner in fee.
