Gentlemen—Attached find copy of a letter dated December 26, 1939, from the Corporation Counsel advising that the Michigan Supreme Court had unanimously confirmed the condemnation award relative to the site of the above project, and assuring the Detroit Housing Commission that it is at liberty to take any and all steps necessary in the matter of letting of bids, etc.

As we desire to proceed at once with construction work on this site, we request your Honorable Body to vacate all public alleys in the blocks bounded by (1) Rowena, St. Antoine, Eliot and Hastings Streets and (2) Rowena, Beaubien, Eliot and St. Antoine Streets. Alleys will not be needed in the new development and they have been vacated in the blocks now occupied by the finished Brewster Homes.
