By Councilman Garlick:

Resolved, that all of north and south public alley in block bounded by Fairport, Joann Avenues, Fairmount and Bringard Drives, Fair, particularly described as all of north and south public alley, 18 feet wide lying between the westerly line of Lots 159 to 174 both inclusive and the easterly line of Lots 212 to 227 both inclusive all of "Grangewood Gardens No. 1," a Subdivision of the S. W. ¼ of the N. E. ¼ of Section 2, T. 1 S., R. 12 E., City of Detroit, Wayne County, Michigan, as recorded in Liber 59, Page 53 of Plats of same is hereby vacated to become part and parcel of the adjoining property.

Provided, that by reason of the vacation of the above described property the City of Detroit does not waive any rights to the lateral sewer located therein and at all times shall have the right to enter upon the premises, if found necessary, on account of said sewer to repair same and further provided petitioners shall not build over said alley without first securing the approval of the City Engineer and the Department of Buildings, and further

Provided, petitioners reimburse the owners to the extent of the value of any utilities now installed in said alley which it may be necessary to abandon due to the closing of said alley or bear the entire expense of relocating or rerouting any public utilities now installed in said alley which it may be necessary to relocate or reroute due to the closing of the same, and further

Provided, petitioners deposit with the Permit Division of the Department of Public Works, the sum of \$58.32, said sum to cover the cost of building new sidewalks on Fairmount and Bringard Drives within the lines of the alley herein vacated, and further

Resolved, that upon compliance with the above provisos the City Controller be and is hereby directed to issue Quit Claim Deed to Edward Mooney, Roman Catholic Archbishop of the Archdiocese of Detroit, of Detroit, Michigan as owners in fee of adjoining property.
